Subject - Humble prayers for constitution of a Judicial Enquiry Commission led by a retired Judge of Hon'ble Supreme Court against disappearance of the Files of AMPS, Registration No - S /6086/1963-64 ,dated 9th March ,1964 for the welfare of crores and crores of helpless and weaker section of the society within the territory of India.

Attaching here the xerox copies of the related RTI applications and the Deed of the Ananda Marga Pracaraka Samgha (AMPS) mentioned above ,your kind attention is arrested to the facts given below which are as follows -

1 That the the Files of the above mentioned Ananda Marga Pracaraka Samgha registered on 9th March 1964 under West Bengal Society Act XXVI of 1961 under the Chairmanship of Shrii P. R. Sarkar have been disappeared from the Mother Office of the Registrar of Firms , Societies and Non- Trading Corporations , Government of West Bengal , Salt Lake Sector -2 ,West Bengal (RTI Reply copy is enclosed herewith this application) under a criminal conspiracy with the Malafide Intention to abolish and crush the objectives of all round social welfare of crores and crores of people of the weaker and helpless section of the society and to conceal the evidences of the serial offences committed by the involved offenders .

2 That the concerned Office has neither any kind of information regarding the date of disappearance of the Files of AMPS nor has lodged any kind of complaint for comprehensive investigation into the matter.

3 That the concerned AMPS has its comprehensive functionings at multilevel planning with structural diversities and working Banking Accounts throughout the territory of India .

4 That only a few hands of Mafias of the Ananda Marga in the Geruwa /Saffron Dresses (fake and fraud Avadhutas)are involved in the conspiracy of disappearing the Files to save themselves from the eyes of the laws for serial offences committed by themselves over a period of three decades after the departure of Physical Body of the Founder of the AMPS namely Shrii P. R. Sarkar dated 21/10/1990 keeping the followers of ANANDA MARGA in complete darkness for their perpetual exploitation and especially from the challenges arising out of registration of false and baseless Title Suit Case No 305/2003 on unlawful ground to claim their unlawful right over AMPS that has been kept pending deliberately and intentionally before Civil Court ,Purulia,West Bengal for more than two decades in fear of disclosure of truth with the active support of the judicial officers and clerks of the concerned courts.

5 ,That only few Mafias in the defined Geruwa Dresses in the said AMPS have established their Monopoly/ Black Imperialism over the AMPS keeping the followers of Ananda Marga in complete darkness deliberately under a conspiracy and have been indulged in blackmailing, cheating, exploiting and depriving the followers of their Natural Rights and the beneficiaries of their welfare.

.6 That most of the Avadhuta Workers of ANANDA MARGA are innocent who have become victims of exploitation, cunningness , brutality and conspiracy of fake Avadhuta Workers who are indulged in blackmailing, cheating , breaking the backbone of trust and defaming Organisation .

7,That I am an RTI activist and have been facing severe torturing and exploitation with frequent kidnapping, frequent fatal assaults, forcibly collection , registration of frequent false cases in

revenge and in defence of disclosing corruption and illegalities committed by corrupt Officials and others since 2015 .

1 Kindly be pleased to pass your kind order for Competent Class of security protection against the danger of fatal assaults of the involved offenders and lodging of false cases in revenge of submitting this application for the public interest.

2 That in case of lodging false case under criminal conspiracy against me any my related ones in revenge and in defence of unearthing this Scam kindly be pleased to hold any action till enquiry by any independent Investigation Agency of the Central Govt.

3 ,kindly be pleased to pass your kind order for setting up a Judicial Enquiry Commission /SIT led by a retired Judge of Hon'ble Supreme Court in a larger public interest.

4 Kindly be pleased to pass your kind order for liberation of all the assets and properties of AMPS from clutches of the offenders wearing Avadhut Dresses to blackmail the people causing irreparable and unrecoverable losses.





Basic grounds of Appeal -

7. Your honour, I have filed application dated on 02/03/2024 under section 6(1) of the RTI Act 2005 to obtain information within specified time limit of thirty days. It is further stated that having been enforced ,the First Appeal has been filed dated on 05/04/024 ,but neither any information nor any reply/notice has been made either by the PIO or by the First Appellate Authority .

8. It is clearly assumed that PIO is found guilty of denial to supply the information deliberately and intentionally to defend illegal activities committed. The demanded information is related to a larger public importance for welfare of crores and crores of the people of the weaker section of the society within the territory of India.

9 The PIO has not only violated the provisions of the RTI Act but also breached the trust and deprived the applicant of his Fundamental Rights under Articles 19 and 21 misusing his /her power and post deliberately and knowingly.

It is, therefore, prayed for passing your kind direction for supply of the demanded information with 25,000 :00 Rs fine and a compensation amount of one lakh Rupees for unrecoverable and irreparable loss of time , energy and resource.



5. SPIO is also directed to inform the third party, if any, so as to enable it to defend or present its case before the Commission. Third Party may choose to be present before the Commission either in person or through its duly authorized representative for hearing, or they may also file a written submission to the Commission before the hearing.
